Recent Project Experience & Career Highlights

Led and supported the development and delivery of policy, design and evaluation processes for AFP law and justice programs in the Indo-Pacific region from 2015-2022. This included AFP efforts in: Tonga; Timor-Leste; Solomon Islands; Papua New Guinea; Vanuatu; Nauru; Samoa; Guam; Federated States of Micronesia (FSM); Marshall Islands; and select countries in Asia, South-East Asia, Europe, and the Americas. **Mixed methodology approaches** and **cross-cultural communication** competencies were at the core of this complex work. The AFP continues to maintain its credibility as a transparent and accountable security partner of choice through these efforts.

Led the Evaluation of the Pacific Transnational Crime Network in Guam, FSM and Marshall Islands. The program enables effective and efficient intelligence sharing across Pacific Island Forum countries, playing an important role in combatting transnational crime. This work included extensive consultations with the Pacific Islands Chiefs of Police and face-to-face consultations across the Pacific region. The evaluation informed a range of subsequent reforms and new initiatives in how the AFP and Australia engages in the Pacific.

Other evaluation projects included leading the Mid-Term Review of the Timor-Leste Police Development Program; the Health Check of the Cyber Safety Pasifika Program, and an Evaluation of the Tonga Police Development Program.

Supported the <u>Regional Assistance Mission to Solomon Islands</u> (RAMSI) drawdown strategy design (police development components), and the development of a program design for the final phase of RAMSI, including support for its implementation and governance arrangements. This led to my role in supporting subsequent development of the <u>Solomon Islands Police Development Program</u> (2017-21) which replated RAMSI, including its policy development and governance arrangements.

Leading the delivery of social impact assessment and stakeholder engagement services for several largescale renewable energy development projects on behalf of <u>Someva Renewables</u> in Cooma (NSW), Hay (NSW), Bathurst (NSW), and Mt Isa (Queensland). This includes the successful delivery of social impact assessment scoping reports; community consultation, including with aboriginal and first nations groups; survey administration; local, state, and federal government engagements; and co-design approaches for developing benefits sharing frameworks and programs linked to these projects.

Facilitated and contributed to research activities, including, <u>The RAMSI Legacy of Policing in the Pacific Region</u>, the AFP's conduct to the lead up to the **Martin Place Siege**, and the **AFP's Regional Pacific Police Development Program.**

Program managed the AFP International Command's **Pacific Police Development Program - Regional** which included overseeing the monitoring and reporting of four project groups across 15 Pacific Island countries. This program has since evolved to become the **Pacific Community of Law Enforcement Cooperation**, inclusive of international efforts to support the **Pacific Transnational Crime Network**.

Successfully managed the relationship between DFAT, and the Attorney General's Office, the Foreign Minister's Office and the Prime Minister's Office.

Represented the Australian Government in negotiations on humanitarian and development resolutions at the United Nations Headquarters in New York.
